Add DOWANOL™ PnB Glycol Ether and Trilon® M Liquid. 6. Adjust pH to 4.5-5.5 with Citric Acid, anhydrous (or Lactic Acid). 7. Add Fragrance, Preservative, and Dye as needed. 8.
