Procedure	<ol style="list-style-type: none"> <li>1. In a suitable vessel equipped with heating and agitation capabilities, charge STEPANOL® AM-CIT/MIT and STEPAN-MILD® GCC with mixing at 45°C until homogenous. Avoid aeration.</li> <li>2. Add Oil and Fragrance with agitation. Mix until homogenous and avoid aeration.</li> <li>3. Add Citric Acid (50% Solution) with mixing.</li> <li>4. In a separate vessel, pre-mix Deionized Water, Farmal MS 6822 and Sodium Benzoate. Heat to 45-50°C..</li> <li>5. Add this premix to the batch under high shearing. A homogenizer is recommended. Mix until homogeneous and avoid aeration.</li> <li>7. Cool to room temperature.</li> </ol>
