Procedure	<ol style="list-style-type: none"> 1. To a suitable vessel, add Deionized Water. Turn on agitation at a slow to moderate speed. 2. Add STEPANBLEND® FF40 with mixing. 3. Add dl-Menthol as a liquid with mixing. Menthol is a solid at room temperature and will need to be liquefied prior to adding it to the batch. 4. Check the pH. Add Citric Acid with mixing to adjust the formulation to the target pH range. 6. Add Sodium Chloride with mixing. 7. Add Blue 1 dye with mixing. 8. Add Preservative.
